Emissions reduction targets

OneMedicare is committed to reaching Net Zero by 2045. To do this, we will start by decreasing our carbon footprint by 10% year-on-year for the next five year.

Note: Over this second year of reporting we will work with suppliers and landlords to gain better data and be able to report a fuller footprint. This means that although we will try to show a reduction in areas such as miles travel and fuel card spend, we may show an increased footprint in 2024.

Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2022 to 2023 baseline footprint was measured.

- ESG Committee in place
- Sustainability working party in place
- Training incorporated in our new starter documents and induction
- Management reviews held and agreement received on implementation of ISO 14001 with aim to have in place by late Spring 2024
- Objectives agreed Board
- Report published on www.onemedicalgroup.com and company intranet

We will be implementing further measures such as:

- Working with suppliers to increase rigour in the data provided to us and enabling us to fuller understand our carbon footprint.
- Working with our landlords, particularly in multi-purpose/multi-occupancy buildings in order to get better data around our energy, water and waste footprints.
- Reviewing how and why we travel, with potential investment in electric cars.
- Reviewing how and what we purchase with the aim of significantly reducing single-use plastics year-on-year.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
