This means that although we will try to show a reduction in areas such as miles travel and fuel card spend, we may show an increased footprint in 2025.

We will be implementing further measures such as:

- Working with suppliers to increase rigour in the data provided to us and enabling us to fuller understand our carbon footprint.
- Working with our landlords, particularly in multi-purpose/multi-occupancy buildings in order to get better data around our energy, water and waste footprints.
- Reviewing how and why we travel, with potential investment in electric cars.
- Reviewing how and what we purchase with the aim of significantly reducing single use plastics year-on-year.

## Declaration and Sign Off


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
